The responsibilities of Officers and Directors-At-Large shall be such as are implied and specified in NACW By-Laws. One (1) Officer will be elected for a one-year term and Seven (7) Directors-At-Large will be elected for a two-year term.

Elections will occur during NACW's 2018 48<sup>th</sup> Annual National Conference to be held in Los Angeles, CA, August 1-4, 2018.

Please review nominee eligibility criteria. All nominees, at the time of nomination, must meet the eligibility criteria and, if successfully elected, through the duration of their term.

NACW By-Laws Article IV, Section 1b states, "No more than three directors shall be elected from any one state."
